TREASURER'S REPORT 2023

This report summarises the income and expenditure of running our two churches and the church centre.

HIGHLIGHTS

The General Fund is our main fund, used for St Mary's Church, the Church Centre and Sale West Community Church. The General Fund had a surplus for the year of £1,556 (deficit of £11,271 in 2022). This is positive compared to the budgeted deficit of £26,900 which the PCC set in order to continue investing in ministry. The difference comes primarily from one off donations.

We challenged the church to grow our planning giving by 10% in 2023, and we achieved 7.4%. We also set a challenge of 20 new regular donors, and 16 new regular donors started supporting us. These continue the growth that started in 2022, following a number of years of declining giving. We need our giving to grow in these times of inflation to continue and grow all that we do. Thank you to all 236 people who gave to God's work here in Sale in 2023, and especially to those who started supporting our work or who increased their giving during the year.

As well as all our regular activities in 2023, your giving and volunteering:

- Enabled us to continuing growing our work with toddlers, children and youth, in line with national church priorities.
- Enabled significant growth in our congregation at Sale West.
- Enabled us to donate £28,889 (10% of giving received) to missions in the UK and overseas, an increase of £1,600 over the previous year.
- Is enabling our church planting initiative, seeking to revitalise the congregation at Sale West and starting new All Nations and Sale Central congregations.

God's provision comes entirely through the generosity of His people here at St Mary's and Sale, and the vicar and PCC thank you for your continuing stewardship of all God gives you.

LOOKING AHEAD TO 2024

For 2024 the PCC has agreed a General Fund budget deficit of £58,000, based on budgeted income of £383,000 and expenditure of £441,000. This is a big challenge, but the PCC believe we should be led by our vision for God's work. We are seeking to grow our children's work, youth work, and the church planting at a continuing time of inflationary pressure on our costs. Our hope and prayer is that church members will get behind the vision and respond with the finance to meet the opportunities, as our predecessors did 150 years ago when they founded St Mary's Church.

We believe that God provides for the work he wants us to do, and he does that through everyone who considers St Mary's and Sale West Community Church to be their church. Please could we therefore ask that you prayerfully consider:

- If you do not yet give financially to God's work through St Marys will you join our Stewardship Scheme? See stmarysaom.org/givingexplained or pick up a pack "Giving To Our Work" in church.
- If you already give, is there scope to increase your giving? Most of us will have received an increase in our income in 2023 and 2024 but the majority of givers have not reflected this in their giving.
- Is God nudging you to give a one off donation? Or to leave a gift to St Mary's in your will?

Income

- Most of the donations we receive come through regular standing orders and stewardship envelopes. We saw an increase of £21,793 in 2023 (£302,036 in 2023 vs £280,243 in 2022), an increase of 7.8%. This was more than the inflation rate of 4.0% which is the first time for a number of years.
- Cash donations were down slightly and are still significantly reduced from before COVID. This may be a sign of a general move away from cash.
- We received one-off donations of £15,059, much greater than in 2022.
- Church centre lettings increased again and are now close to the level they were in 2019 prior to the pandemic.
- Our total income was £378,115, which was £42,010 more than the previous year.

Expenditure

- Our electricity prices went up by a factor of 2.4 from July 2023, and our fixed rate gas contract is due for renewal in July 2024.
- Our total expenditure was £356,559, which was £29,183 more than the previous year.

MAINTENANCE & DEVELOPMENT FUND

The Maintenance and Development Fund is used for maintenance of our buildings and new development projects. Since we know these will be required but don't know when, we aim to transfer £20,000 into this fund from the General Fund each year.

- In 2023 we transferred £20,000 from the General Fund into the Maintenance and Development Fund as planned.
- We replaces the sofas in the foyer, painted the hall and south porch, and made repairs to the church tower and roof.
- The insurance claim was for a lightening strike on the evening of 12th June 2023 which damaged a computer in the office, networking routers and audiovisual equipment in church. The claim was paid in full apart from the £250 excess.
- The surplus for the Maintenance and Development Fund for the year was £13,273 (£19,717 deficit in 2022). This left a balance of £117,794 as at 31 December 2023.
- It is our policy to maintain approximately 3 months of regular expenditure in our Maintenance and Development Fund. At the end of 2023 we had 4.0 months (3.8 months at the end of 2022). The PCC consider this sufficient to continue to move forward with confidence.
